

**2017 State 4-H/FFA Dairy Youth Field Day**  
**Saturday, June 10, 2017**

The 2017 State 4-H/FFA Dairy Youth Field Day will be held on Saturday, June 10 in Clarke and Frederick Counties. The contest will be hosted by Harvue Farm in Berryville and Waverly Farm in Clear Brook. Check-in will begin at 9:00 AM at Harvue Farms and the contest will start at 9:30 AM. The contest is expected to conclude at 3:00 PM at Waverly Farm.

**Contest Information**

Teams will consist of three or four members. When four members are entered, the three members with the highest individual scores will be used for the team score. All contestants will judge four classes of Holsteins at Harvue Farms and four classes of Jerseys at Waverly Farm.

**4-H Divisions**

Juniors: 9 to 13 years old as of September 30, 2017

Seniors: 14 to 18 years old as of September 30, 2017

Note: Youth born between January 1, 2003 and September 30, 2003 have the option of choosing to compete either as a junior or a senior.

Junior 4-H contestants will present one set of oral reasons and senior contestants will present three.

**FFA Division**

There will be one FFA division. FFA contestants will present two sets of oral reasons.

Note: Youth will be allowed to count their scores in a 4-H division and the FFA division provided that they are bona fide members in each organization.
